

The server security sweep is almost finished and email should be fully restored shortly after noon for all of you


Chairman Harnett Contacts Computer Plumber (NC GOP email service provider)

- Don't you think all emails would be cut off if there was a security threat?


Chairman Harnett Screenshots Facebook MSG - Unsolicited Hack of NC GOP Website by Ken Robol

Ken Robol first contacted Chairman Harnett via Facebook on March 7th, 2016. This is a screenshot of the conversation.




Chairman Harnett Screenshots Text MSG - Unsolicited Hack of NC GOP Website by Ken Robol

Phone Conversation on March 10th between Mr. Robol and Chairman Harnett, two days after Dallas Woodhouse shut the Chairman out of his email because of a “security threat”.

- Mr. Robol called Chairman Harnett on March 10th explaining to Chairman Harnett that he could hack into the website and gain access for the Chairman. Chairman Harnett did not solicit the hacker’s services, and never ordered the hacker to hack the NC GOP website.

Ken Robol Information

- Ken Robol is the website coordinator for the 3rd Congressional District NC GOP.
- Ironically, the organizer of the petition to call the Central Committee meeting on March 20th to censure Chairman Harnett was the 3rd Congressional District Chairwoman Kim Cotton West.
- After Ken Robol's phone conversation with Chairman Harnett on March 10th, Robol went immediately to Tom Stark (NC GOP General Counsel) to make a bogus statement that Chairman Harnett was trying to hire Robol to shutdown the NC GOP website.

March 20th Central Committee Meeting Out of Order

PLAN OF ORGANIZATION:

"ARTICLE VI - STATE ORGANIZATION

B. STATE CENTRAL COMMITTEE

3. Meetings

The State Central Committee shall meet at least every other month upon the call of the Chairman with 10 days notice to all members, or upon petition of 1/3 the members with **10 days notice** to all members. Twenty Five percent of the Members listed in Article VI, B.1.a through 1.d shall constitute a quorum for the transaction of business."


'ARTICLE VII - GENERAL ADMINISTRATIVE PROCEDURE

J. Notice

1. "Written Notice" as used in this plan shall mean notice sent through the **United States Postal Service (USPS)** first class mail.
2. The date **post marked by the USPS** shall be conclusive as to the date notice was given.'



